This supplement (the "Supplement") is the second supplemental prospectus to the EUR 5,000,000,000 Conditional Pass-Through Covered Bond Programme (the "Programme") of Achmea Bank N.V. (the "Issuer") and is prepared to update and amend the base prospectus dated 5 March 2020 as supplemented on 20 March 2020 (the "Base Prospectus") and is supplemental to, forms part of and should be read in conjunction with the Base Prospectus. Terms defined in the Base Prospectus shall have the same meaning in this Supplement, unless specified otherwise.

This document is an amendment and a supplement to the Base Prospectus within the meaning of Regulation (EU) 2017/1129, including any commission delegated regulation thereunder (the "Prospectus Regulation"). The Dutch Authority for the Financial Markets (*Stichting Autoriteit Financiële Markten*) (the "AFM") only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. Such approval should not be considered as an endorsement of the Issuer that is the subject of this Supplement nor as an endorsement of the quality of any Covered Bonds that are the subject of this Supplement. Investors should make their own assessment as to the suitability of investing in the Covered Bonds.

MODIFICATION TO THE BASE PROSPECTUS

The following are amendments to the text of the Base Prospectus.

1. In section 3 (*Risk factors*) under risk factors regarding the Issuer the risk factor 'Coronavirus outbreak may have a negative effect on the financial position of the Issuer' shall be deleted and replaced as follows:

"Coronavirus outbreak may have a negative effect on the financial position of the Issuer

The outbreak of Covid-19 / Coronavirus disease 2019 ('Coronavirus') may have a severe impact on the Dutch, European and global economic prospects and therefore on the Issuer. Various countries across the world have introduced measures aimed at preventing the further spread of the Coronavirus, such as a ban on public events above a certain number of attendees, temporary closure of places where larger groups of people gather such as schools, sports facilities and bars and restaurants, lockdowns, border controls and travel and other restrictions. Such measures have disrupted the normal flow of business operations in those countries and regions, have affected global supply chains and resulted in uncertainty across the global economy and financial markets.

The balance sheet of the Issuer mainly consists of a mortgage loan portfolio and loans to professional counterparties (financial institutions) (see also risk factor 'The Issuer has significant counterparty risk exposure'). The outbreak of the Coronavirus and the measures taken in relation thereto, will directly or indirectly result in increases of defaults under mortgage loans and may directly or indirectly result in increases of defaults under loans to professional counterparties. Payment holidays have been requested and more are likely to be requested by borrowers in distress due to the Coronavirus, and many of which have been accepted pursuant to which borrowers are allowed to defer making payments for three months. This may result in payment disruptions and possibly higher losses under the mortgage loans and loans to professional counterparties.

The outbreak of the Coronavirus and the measures taken in relation thereto, will therefore have a negative effect on the financial position and prospects of the Issuer. However, it is too early to predict the scope and extent of the consequences of the outbreak of the Coronavirus and the consequences of the measures taken in relation to the Coronavirus and conditions may worsen and measures may become more restrictive in the future."

- 2. In section 5 (*Achmea Bank N.V.*) under 'Financial figures' on page 68, a new first and second paragraph will be inserted before the paragraph starting with "On 13 March 2020 [...]":
 - "On 20 April 2020 the Bank published its annual figures over 2019. The annual report is available on the website https://www.achmeabank.com/investors/annual-reports".
 - On 10 April 2020, the Bank published a press release regarding dividend payments. The press release is available on the website https://www.achmeabank.com/news".
- 3. In section 5 (*Achmea Bank N.V.*) under 'Recent developments' on page 68, a new first paragraph will be inserted before the paragraph starting with "Achmea Bank completed the acquisition [...]":
 - "On 10 April 2020, Achmea Bank published a press release in which it announced its decision to suspend dividend distributions to its shareholders until there is greater clarity regarding the impact of the Coronavirus. By taking this action, the company follows the advice from the ECB and DNB. In the second half of 2020, Achmea Bank will determine if a distribution on the shares can still be made, based on developments related to the Coronavirus and its financial position."
- 4. In section 19 (*Documents incorporated by reference*), on page 189, the following new paragraphs (i) and (j) shall be inserted (with the deletion of "and" at the end of paragraph (g)):
 - "(i) the English language publicly available audited consolidated financial statements as of and for the financial year ended 31 December 2019 of the Issuer, which can be obtained from: https://www.achmeabank.com/ cache/achmeabank/com/ cache/achmeabank/media/jzxfp97132/Annual Report Achmea Bank 2019.pdf?hash=82a9c2cd3f8c0145; and
 - (j) the press release titled "Achmea Bank N.V. suspends dividend distributions" dated 10 April 2020, which can be obtained from https://www.achmeabank.com/ cache/achmea-

bank/media/epuzc96909/Press release Achmea Bank suspends dividend distributions .pdf?hash=7ff3bd15e442 a39d.".

5. In section 20 (*General information*) under 'Significant/Material Change' on page 191 shall be deleted and replaced as follows:

"Significant/Material Change

Up to the date of the Base Prospectus, other than as disclosed in the new first paragraph of the subsection 'Recent developments' in section 5 (Achmea Bank N.V.) above, there has been no significant change in the financial performance and position of the Issuer since 31 December 2019 and, other than as disclosed in the subsection 'Coronavirus outbreak may have a negative effect on the financial position of the Issuer' in section 3 (Risk Factors), there has been no material adverse change in the prospects of the Issuer since 31 December 2019, the last day of the financial period in respect for which audited financial statements of the Issuer have been prepared."

6. In section 20 (*General information*) under 'Auditors' on page 191, the first sentence shall be deleted and replaced by the following two sentences:

"PricewaterhouseCoopers Accountants N.V. ("PwC"), an independent registered public accounting firm located at Thomas R. Malthusstraat 5, 1066 JR Amsterdam, the Netherlands, audited the Issuer's financial statements as of and for the financial years ended 31 December 2017, 31 December 2018 and 31 December 2019, in accordance with generally accepted auditing standards in the Netherlands and issued unqualified auditors' reports for the financial years ended 31 December 2017, 31 December 2018 and 31 December 2019. The auditor's report on the financial statements for the year ended 31 December 2019 of the Issuer contains an emphasis of matter on the uncertainty related to the effect of the Coronavirus."
